Erik Holmstrom

Erik Holmstrom is an associate in McLennan Ross's Bankruptcy & Insolvency and Commercial Litigation groups. A graduate of TRU Law (2019), Erik brings a strong academic and practical foundation to his practice.

During law school, Erik was an active member of TRU's Rugby Team and served as Editor-in-Chief of Obiter, Thompson Rivers University's student newspaper. In his third year, he published an article in the Western Journal of Legal Studies titled "Dancing in the Dark: An Analysis of the Live Entertainment Industry and the Deceptive Market Practices of Ticketmaster and Live Nation," examining Live Nation's business practices under Canada's Competition Act.

Erik gained early legal experience as a Clerk of the Court and summer student with the Government of Alberta's Labour and Employment Division. He joined McLennan Ross as an Articling Student in 2019, was called to the Alberta Bar in 2020, and the Northwest Territories Bar in 2022.

What's the best piece of advice you've received from another lawyer?

Two pieces of advice have really stayed with me. First, outside the practice of law: enjoy law school. The legal profession is demanding, time-consuming, and rewarding, but law school is one of the last opportunities to truly enjoy your free time. Make lasting memories—spend time with friends, take that trip you've always wanted, or head up to Sun Peaks for a spontaneous ski day.

Second, in practice: don't be afraid to pick up the phone and call opposing counsel. It's easy to forget that behind every email is a person. Too often, lawyers get stuck in endless email exchanges instead of having a real conversation. I've settled countless files simply by calling counsel and talking things through—it's amazing how effective that can be.

Would you recommend law students enroll in any specific classes?

Not necessarily one specific class, but I recommend focusing on courses that cover broad areas of law—such as Trusts, Real Property, and Creditor Remedies—rather than paper-based courses. While paper courses can be interesting, having a strong foundational understanding of major areas of law makes research much easier. It gives you a starting point, rather than trying to learn an entire subject from scratch, and will save you long, sleepless nights.

What is your favourite memory from TRU?

Building a close-knit group of friends who I could study with and make lasting memories alongside—playing cards, sharing beers, and going on trips together. Some of my best friendships started at TRU, and I wouldn't trade that experience for anything.
