For me, one of the most rewarding things about business law practice is finding successful resolutions or achieving successful results for our clients. Are there any skills or experiences from your time at the BLS that helped you in your work?

Being involved with the BLS taught me the importance of effective collaboration and communication, skills which I believe have helped me in practice. In many ways, being a law student is a "self-focused" exercise; one must often prioritize one's own studies, grades, applications, etc. However, this is not often the case in legal practice. In my current work which focuses on corporate mergers & acquisitions, multiple lawyers and business experts will come together as a single team to effect large transactions. Everyone has an important role to play as we lead a deal towards closing, and the skills of effective collaboration and communication are critical in this endeavour. During my time as a member of the BLS, I had the chance collaborate with and learn from some amazing colleagues, and I continue to enjoy collaborating with others in my current practice.





Would you recommend that students interested in business law enroll in any particular classes?

Because it is such a vast and dynamic area, I believe students interested in business law should take as many business-related courses as they can during their time in school. This will allow them to gather a solid picture of the many business law practices that exist in the legal profession. During my time at TRU Law, I found courses such as Securities Law, Mergers & Acquisitions, Basic Tax, Corporate Tax, and Secured Transactions to be guite valuable, as they provided a solid introduction and foundation in areas of law with which I now frequently engage. However, I note that business law is also a practice that cannot be summed up in a single academic course, and I have found that a lot of my learning continues to take place as I immerse myself in my current practice, supplemented by the academic courses I took at TRU.
