#### What is your favourite memory from TRU?

## **Would you recommend that students interested in business** law enroll in any particular classes?

In addition to the mandatory 1L contracts class and upper-year business associations, I highly encourage students to consider enrolling in a few elective courses with a business focus. I personally found the mergers and acquisitions course to be exceptionally beneficial for both PLTC and gaining a fundamental understanding of a contract and how to draft clauses. Additionally, I would encourage students to take courses such as unjust enrichment, secured transactions, and real estate.

While an advanced research and writing class may not have a direct business connection, I encourage students to take one. Regardless of your chosen area of legal practice, including a career as a solicitor, research skills are indispensable and will be useful during your articles and into any area of practice. This class increased my confidence in my research abilities during my articling period and proved invaluable for solicitor-type work as well.

## Are there any skills/experiences from your time at the BLS that helped you in your work?

During my time as an executive with the BLS, I acquired several crucial skills that have proven essential in my legal career. Networking with business lawyers was one of the key skills I developed. The events we organized provided opportunities to connect with like-minded professionals. This skill is vital in the legal profession as it opens doors to new opportunities, mentorship, and eventually the establishment of client relationships.

Teamwork was another skill I improved on while serving in different roles at the BLS, from being an event coordinator to co-president. Collaborating with fellow BLS executive team members on various projects and initiatives enhanced my ability to work effectively as part of a team. This skill is particularly important in law firms, where teamwork is often required for files, and close cooperation with other articling students is common.

Participating in the club also helped me refine my time management skills. Balancing club activities with coursework and personal commitments proved to be a valuable experience. This ability has been essential in my current role, enabling me to efficiently handle various tasks at work, meet deadlines, and manage personal commitments outside of the workplace.
