## Alumni Spotlight: Paige Mueller

Graduating in 2021, Paige was deeply involved in the law community during her time at TRU. She was part of numerous societies and student initiatives, including the TRU Law Human Rights Club, TRU Environmental Law Club, TRU Law Oral Advocacy Club, and the TRU SLS Conference. Paige also volunteered with Pro Bono Students Canada, served as Co-Chair of the Society of Law Students Legal Conference, and was an executive of the TRU Pan-Asian Law Students Society. In her final year, Paige represented TRU at the Wilson Moot and was an editor of the Canadian Journal of Comparative and Contemporary Law. Paige was also awarded Dean's Course Prizes in Civil Procedure and Insurance Law, and was a Dean's List recipient.



After articling with Fasken, Paige is now a Judicial Law Clerk at the Supreme Court of British Columbia.

#### What is your favourite memory from TRU?

I have so many great memories from TRU, so it's hard to narrow down to one! I think my favourite memory is studying/hanging out in the library with my friends. # Are there any skills or experiences from your time at TRU that helped you in your work?

#### What were your favourite classes at TRU?

My favourite classes were employment law and insurance law with Professor Ted Murray. After the required courses of 1L and 2L, I was excited to take electives that interested me. Professor Murray offered practical and thorough lectures that taught me a lot of skills that I carried into articling – even though my practice will not focus in either area.
